#### **HPC Site update**

#### Site Progress:

- Focus areas Unit 1 Nuclear Island, Unit 1 Conventional Island, Unit 2 Nuclear Island, and Tunnelling
- J0 Unit 2 on track 4/5 pour first week in May
- U1 Tunnelling now 500m under Bristol Channel

#### Social distancing measures:

Measures now embedded and working well

#### On Site we have:

Significantly reduced the number of workers on site from over 4,000 to around 2,300. All workers who are able to work from home have been doing so.

Added 60 new buses to the fleet to reduce the number of workers on each bus – buses now only 30% full. Screens are also fitted on buses to protect the drivers.

Increased our cleaning regime across site, including regular antibacterial cleaning on buses and on touch points.

Introduced floor markers across site (including for queuing in canteens/ at bus stops) to mark 2m between each person. In the canteens, allowing only one person to sit per table of 4 chairs.

#### In the Community we have:

Stopped servicing individual bus stops and instead pick workers up from the Park & Ride's / Campuses where social distancing can be managed.


Opened the campuses free of charge for non home based workers, to increase the safety of the community

Introduced temperature checks (using thermal cameras) on all workers at the Park & Ride's and site entrance.




Thermal Imaging cameras in operation





#### 6: Thermal Imaging Cameras installed






















#### **HPC Site Statistics – Type of Injury / Event**

# ONR Site Stakeholder Report Highlights

May 2020 - Update



## ONR Reports- Q3 2019

- Quarter 3 2019 Report
  - LC06 Documents, records, authorities and certificates ONR identified that whilst appropriate records were being made, the timeliness of submission to NNB required improvement
  - LC07 Incidents on the site ONR found that whilst NNB had made a number of improvements in relation to organisational learning, a number of further improvements were required to ensure that NNB GenCo(HPC) is effectively managing its organisational learning and associated processes.



## ONR Reports- Q4 2019

- Quarter 4 2019 Report
  - ONR has issued a routine specification that NNB shall not commence the bulk installation of mechanical, electrical and HVAC (MEH) equipment without ONR's agreement – this is issued to ensure regulatory control of NNB's transition to bulk MEH installation



## ONR Reports- Q1 2020

- Quarter 1 2020 Report
  - LC09 Instructions to persons on the site whilst NNB had clearly expended significant effort in ensuring site personnel's understanding of the meaning of site alarms and the action to be taken in response to them leading to some improvement, some improvements are judged necessary to demonstrate they are fully effective
- Covid-19 Impact
  - ONR has transitioned to remote working but remain available to travel to site if required
  - Enhanced reporting and oversight measures have been implemented to ensure oversight of nuclear safety and conventional health and safety
  - ONR has oversight of NNB's Covid-19 control measures and continues engagement to ensure their effectiveness



## ONR Reports- Q1 2020 Cont...

- Quarter 1 2020 Report
  - ONR issued a routine specification to NNB due to legislative changes regarding the reporting of High Activity Sealed radioactive Sources (HASS).
  - This specification has been issued to all licensees and was required to enable implementation of revised European legislation
