

LOCAL NOTICE TO MARINERS No. 07 OF 2022

Hinkley Point C Marine Works Offshore Area Gravel Bed Installation Works

Issued: 22/04/2022

Mariners are advised that from Monday 25th April Multipurpose Pontoon 'Naseem' will commence gravel bed installation works, with the assistance of Rock Barge 'Osprey Carrier II.'

These vessels will be supported by Tug 'Noordstroom' and 'Brutus', Crew Transfer vessel 'Commander-P' and accommodation vessel 'DP Gezina.' Survey vessel 'Faraday' will be carrying out survey work.

Gravel bed installation work will be conducted in the area as shown on the chart extract below. (Within works in progress area - highlighted by grey border).

Operations will take place during the day and night and are expected to last until approximately July this year.
