Fish Return System Offshore Outfall Head and Tunnel Ramp Installation with TBM Recovery

Mariners are advised that from 01/03/26 till 31/07/26, the vessels listed in the below table will be engaged in the installation of an outfall head and tunnel ramp works. This activity forms part of the HPC – Fish Return System offshore scope to allow for the installation of the concrete outfall tunnel headwall structure and TBM recovery.

There will be durations at which divers will be in attendance to support the works and International Maritime Signal Flag Alpha will be deployed at these times.


At times when the Maritime Signal Flag Alpha is deployed, a 500m Clearance Safety Zone will be in place around the dive vessel/platform.




Figure 1: Haven SeaChallenger

All vessels listed will be restricted in their ability to manoeuvre when towing and on operations in the works area, and will display the signals prescribed by the International Regulations for Preventing Collisions at Sea, 1972 (as amended).
