Domestic End Users

- Significantly less able than a typical consumer to protect or represent his or her interests in the energy market; and/or
- Significantly more likely than a typical consumer to suffer detriment, or that detriment is likely to be more substantial
- blind, partially sighted, deaf or hearing-impaired”

- Pensionable Age
- Any person with a disability or chronic illness;
- An informed third party, such as a carer, social worker, health visitor or physician has indicated that a person may be vulnerable;
