

Where the Customer has selected the EDF Free Miles the following terms shall apply:

10,000 driving miles, equating to an energy value of 2,857kWh and a monetary value of £128.57 including VAT*, credited to the customer's electricity bill after delivery of the vehicle to the customer's property.

(*The 10,000 miles is calculated on an average driving efficiency of 3.5 miles per kWh** of charge and EDF's GoElectric35 tariff's current off-peak rate kWh price of 4.5p/kWh (correct as of 12th December 2021) (the "Offer").
