

Hinkley Point B power station

June 2014 monthly report

Introduction

This is our latest monthly report, sharing news with our local community stakeholder groups and local councils. This forms part of our commitment to being an open and transparent business. These reports are also available to all members of the public on www.edfenergy.com website.

Safety update

Hinkley Point B measures its safety performance against top tier indicators, including nuclear reportable events, environmental events, and staff and contract partner recordable injuries. It is now over seven and a half years since we experienced a nuclear reportable event, and over five years since our last environmental event.

A nitrogen injection line was being tested on Wednesday 2 July when there was a failure of a piece of pipe that goes through the wall into the circulator hall of reactor 4. Clean nitrogen was released from the pipe and some lagging and cladding debris was blown into the circulator hall. There was no contaminated dust involved or any injuries sustained. The injection line is part of the back up systems for shutting down the reactor. The station is carrying out an investigation into the event, and in line with normal procedures has informed the Office of Nuclear Regulation. The pipe has since been successfully repaired.

Station generation

Reactor 3 has been on line since 19 March 2014, and operated at nominal full load throughout June. Reactor 4 has been on line since 10 June 2013, and operated at nominal full load throughout June

Benchmarking visit by EDF Nogent-sur-Seine

In June we hosted a successful benchmarking visit to staff from EDF's Nogent-sur-Seine power station in France. The visit was arranged as part of a company programme to forge stronger links with our French counterparts.

Nogent-sur-Seine nuclear power plant is located on the River Seine and is approximately 120km from Paris. The plant houses two 1300 megawatt reactors and employs over 700 workers. The team who visited Hinkley B focused and learned more about our human performance, continuous improvement, training and communications processes.

Charity partnership reaches £350,000

EDF Energy has marked the first year of its charity partnership with Marie Curie Cancer Care by holding a Parliamentary reception. In 12 months the energy company and its employees have raised more than £349,000 for Marie Curie, which exceeds its target figure by nearly £150,000. The reception was hosted by Michael McCann MP and attended by dozens of Parliamentarians, Marie Curie employees and members of staff from EDF Energy. Office for Nuclear Regulation approves Dungeness B's graphite limit

The Office for Nuclear Regulation has approved the limit of graphite weight loss at Dungeness B to 8%. This is a small increase from the previous limit of 6.2% and refers to the amount of weight the graphite core is allowed to lose. Dungeness B has used the information from a continuing programme of monitoring, inspection and physical sampling of the graphite core to assess the state of the core.

This knowledge feeds in to modelling and analysis which give us the knowledge to allow us to safely increase the limit of weight loss within the core from 6.2% to 8%. As time goes on we will continue to collect data, build this into our models and calculations and ensure our safety margins are robust and appropriate
