Safety update

We measure our safety performance against top tier indicators, including nuclear reportable events, environmental events, and staff and contract partner recordable injuries. It is now over twelve years since we experienced a nuclear reportable event, over nine years since our last environmental event, over two years since the last employee lost time incident, and over one year since our last contract partner lost time incident.

Station generation

Reactor 3 has been on-line since 9 June 2018, and operated at nominal full load throughout November. Reactor 4 has been on-line since 30 May 2018, and operated at nominal full load throughout November.
