The principal activity of the Company is acting as an intermediate holding company of EDF Energy Nuclear Generation Limited (**ENGL**).

The Company is non-trading, dormant and has no employees, customers or suppliers. As a result of this, the breadth of stakeholder and other considerations that would often apply to decision making for those operational companies within the Company's wider group, Lake Acquisitions Limited Group, being Lake Acquisitions Limited and its subsidiaries (the **Lake Group**) have generally not applied to the decisions made by the Directors of the Company. The Board's decisions in the reporting year have been limited solely to the approval of the Company's Annual Report & Financial Statements.
